  - Three letters of recommendation (School Principal, Recent Marching or Concert Band MPA Adjudicator of the nominee's band program, and one other FBA member due to the Award Committee Chair by Nov 1)
  - A committee will select the award recipients based on the application and other outside knowledge
  - 0 4 Hobbs recipients selected per year overall.
  - No limit to Bishop recipients selected overall per year (only <u>one</u> per District submitted).
